To the contrary, that Court's holding is consistent with the rule adopted by this court in Pacific Mutual Life Insurance Co. v. Haslip, 499 U.S. 1, 111 S.Ct. 1032, 113 L.Ed.2d 1 (1991). In Haslip, which concerns a challenge to punitive damages awarded by a jury, the Supreme Court held that "an award of punitive damages in an amount that is not rationally related to the harm caused to the plaintiff and the necessity of preventing similar harms from happening to other potential plaintiffs" constitutes an excessiveness problem requiring remittitur. Id., 111 S.Ct. at 1046. The Supreme Court explained: "If the number of permissible [punitive] awards is to be limited so as to avoid truly 'outrageous' results, it is difficult to see why, in an attempt to draw the

line between sufficient and excessive punitive damages, a State court would not end up with too many awards that are within constitutional limits, and too few that are excessive." Id. For the foregoing reasons, the court reaffirms its holding that there is no absolute rule prohibiting juries from awarding punitive damages in cases such as the one at bar. F. The defendants next object that the award for punitive damages is not supported by the evidence. In Riggs National Bank of Washington, D.C. v. District of Columbia, 581 A.2d 1229, 1246 (D.C.1990), the court explained: "Punitive damages are awarded to punish the wrongdoer for his outrageously or wantonly abusive behavior and to deter him and others from similar conduct in the future." At trial, the defendants argued that the punitive damages award was excessive because there was evidence that they \square like other dentists \square were being forced by the Dental Board to seek out unnecessary procedures in order to generate *1315 revenue and to increase their staff size, and they could have earned \$10,000 to \$15,000 per year without unnecessarily performing unnecessary procedures.
